    - For example, Double Commissions earned as part of the October PV month will be paid on or around November 25 when you are on Direct Deposit. If you are not on Direct Deposit, the Double Commissions will be paid with your next PV month check.
    - Any Star Club and Prove It Bonuses earned during the promotional period will also be doubled. Regular standard Star Club and Prove It Bonuses will be paid daily as normal, and a matching amount will be included in the Double Commissions payment on or around the 25<sup>th</sup> of the month following PV month close.
